Accordingly, show cause notice was issued to the institution on 25.09.2009.

AND WHEREAS, the reply received in response to the Show-cause notice was considered by NRC, in its 151st held on 20th & 21" October, 2009 and committee decided to sent VT to verify the facts. The inspection letter was issued to the institution on

AND WHEREAS, the inspection of the institution was conducted under section 14 on 05.04,2010. The original file of the institution, VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 161" meeting held from 23th to 29th May, 2010 and the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution of 10.01.2010.

AND WHEREAS, the matter was considered by the NRC, in its 165th meeting held on 01th 2nd September, 2010 and committee decided that the letter of intent under clause 7(9) be issued. Accordingly, letter of intent under clause 7(9) was issued to the institution on 18,11,2010.

AND WHEREAS, the reply of the institution dated 28.03.2011 submitting details of the faculty appointed & the university vide its letter dated 17.03.2001 was has been considered by the NRC, in its 182 meeting held from 15th to 21th May, 2011 and committee decided that the grant formal recognition under section 7(11) of the NCTE Regulation, 2009 for B.Ed. Course with annual intake of 100 seats from the academic session 2011-2012 be issued to the institution.

One year Course with an annual intake of 100 (Hundred Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
