ORDER

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Desh Deepak Adarsh Mahila Mahavidyalaya, Village - Tendua Mafi Bikapur, Post- Bikapur, Tehsil - Bikapur, District - Faizabad - 224204 Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for B.Ed Course of one year duration with an annual intake of 100 (Hundred Only) students on 31.10.2008.

AND WHEREAS, the matter was considered by the NRC, in its 141st meeting held from 22nd to 24th May, 2009 and committee decided that the letter of intent prior to inspection is to be issued. Accordingly, letter was issued to the institution on 30.05.2009.

AND WHEREAS, the inspection of the institution was conducted under section 14 on 28.05.2009. The original file of the institution, VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 149th meeting held on 13th & 14th September, 2009 and the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 25.09.2009.

AND WHEREAS, the reply received in response to the Show-cause notice was considered by NRC, in its 151st held on 20th & 21st October, 2009 and committee decided to sent VT to verify the facts. The inspection letter was issued to the institution on 17.03.2010.

AND WHEREAS, the inspection of the institution was conducted under section 14 on 05.04.2010. The original file of the institution, VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 161st meeting held from 23rd to 29th May, 2010 and the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 10.01.2010.

AND WHEREAS, the matter was considered by the NRC, in its 165th meeting held on 01st & 2nd September, 2010 and committee decided that the letter of intent under clause 7(9) be issued. Accordingly, letter of intent under clause 7(9) was issued to the institution on 18.11.2010.

AND WHEREAS, the reply of the institution dated 28.03.2011 submitting details of the faculty appointed & the university vide its letter dated 17.03.2001 was has been considered by the NRC, in its 182nd meeting held from 15th to 21st May, 2011 and committee decided that the grant formal recognition under section 7(11) of the NCTE Regulation, 2009 for B.Ed. Course with annual intake of 100 seats from the academic session 2011-2012 be issued to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Desh Deepak Adarsh Mahila Mahavidyalaya, Village - Tendua Mafi Bikapur, Post- Bikapur, Tehsil - Bikapur, District - Faizabad - 224204 Uttar Pradesh for conducting B.Ed. One year Course with an annual intake of 100 (Hundred Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
